General Terms and Conditions of Sale

1/ Our Services

Bare pitch, 6 people maximum

This consists of a bare pitch for your tent, caravan or camper (max 7 meters). Your stay is calculated on a basic package that includes the pitch, the person(s) expected according to the offer selected, your installation, your vehicle and access to reception, activities and sanitary infrastructures. The additional costs (additional person, vehicle, pets, etc.) are not included in the package and will be added.

Nature: Pitch for 2 people, 1 camper or 1 car with a tent or a caravan

Comfort: Nature offer + electricity

Privilege: Comfort + BBQ and fridge

Rented Accommodation

Our prices include: the people (according to the capacity of the accommodation), water, gas, electricity, one vehicle, access to the reception, activities and sanitary infrastructures.

Your wishes for a precise pitch or accommodation at the campsite can be met according to our availability at the time of your arrival.

Your accommodation must be handed back in the same state at the time of your departure. Please, treat the ground, water supply, electricity supply, vegetation, other facilities etc... with respect. Otherwise additional costs may be charged.

Delivery of keys

For pitches, arrivals at any day of the week.

Arrival: 1pm and departure: 11 am.

For accommodations, three days possible in high season: Saturday, Monday and Wednesday, and any day of the week in low season. Arrival: 2pm and departure: 10am. After 10am, an additional day will be charged.

Related Activities

All the activities mentioned in this document, whether free or not, may be in certain circumstances modified or cancelled beyond our control, when you arrive at the campsite. In this case, our responsibility will not be engaged.

Extra charges

Whatever the package selected, additional costs will be invoiced for additional people, visitors... Tourist tax is not included in our prices and has to be invoiced and paid together with the accommodation. It cannot be modified or refunded on your arrival at the campsite (Tourist tax: 0.61cts per night and person over 18, rates can be subject to change without notice).

2/ Payment for the stay

Modes of payment accepted

For deposit or balance, you can pay for your booking or your stay using the following payment methods: by French bank cheque or postal cheque, credit card, postal order or cash order. Possibility to pay your balance in 3 times (excluding deposit)

Terms of Payment

All requests for a firm booking from the buyer must be indicated in writing and be provided with the following:

- Payment of a deposit of 25% of the costs of the stay
- Booking fees are offered
- And the payment for cancellation insurance

This booking is only of contractual value when the buyer has received a booking confirmation issued by the campsite.

The balance of the stay must be paid 30 days before the stay begins at the latest. In the case the balance has not been paid on the deadlines indicated, the booking shall be considered as cancelled, and the cancellation terms indicated below shall apply.

3/ Last minute booking

Any booking made within a period of 30 days before the date of departure must be paid in full, using a bank card only.

4/ Late arrival or early departure

In case of a late arrival or early departure, with respect to the date mentioned on your booking voucher, the total amount of the stay remains due. You shall not be entitled to claim any refund for the part of the stay not actually used.

5/ No arrival at the campsite

In the case where no one comes to the campsite within a period of 48 hours from the beginning of your stay, and without any proof and/or news of your arrival, we shall be able to relocate your accommodation. We shall keep the fees as per our cancellation terms.

6/ Cancellation

Due to the buyer:

All cancellations must be notified by post, which shall go into effect on the date of receipt of the letter:

- More than 30 days before arrival, the amount of the deposit shall be kept by the campsite.
- Less than 30 days before your arrival, the total amount of the rented accommodation, booking fees and insurance fee shall be kept.

For possible damages, we ask you to take out cancellation or interruption insurance at the time of your booking.

Due to the campsite:

If the Camping Marius is obliged to cancel its rental of a bare pitch and/or rented accommodation that appears in this brochure, any contracting party having received its confirmation of stay, shall be informed by registered letter and reimbursed in full for the amount it has paid.

In case of force majeure:

Force majeure included: any fortuitous events, strike, partial or total interruption of work, lock-out, fire, riot, intervention of civil or military authorities, declared or undeclared acts of war...

In case of force majeure, the party which are not able to fulfil its obligations should be informed without delay, the other one, and propose alternative solutions.

7/ Lost, stolen and damages

Camping Marius declines any responsibility in case of lost, theft, fire or degradation on personal effects, or for any other reason concerning the campsite's responsibility.

8/ Deposit

For rented accommodation, you will be requested to pay a deposit of 30 EUR (including 80€ for linen provided and 80€ for housecleaning at the end of stay) on your arrival, which will be returned to you at the end of the stay no later than eight days by post from the date of your departure.

The campsite reserves the right to keep part or the total amount of the deposit in case of deterioration of the accommodation and its content and/or facilities at the campsite. The campsite also reserves the right to deduct the costs of cleaning not carried out at the time of departure.

Clients should inform the reception office one day before their checkout if they need to leave the campsite before the opening time.

200€ per bike and 300€ per canoe.

In case of degradation in our accommodation, Camping Marius reserves the right to keep some or all the deposit.

Clients are informed and accept to pay a surcharge in case of serious degradation. (higher amount than the deposit)

9/ Minors

Minors not accompanied by their parents cannot be accepted at all in the campsite. Bike riding and ball games are forbidden inside the campsite except in designated areas. Children are under parent's responsibility.

Children under 2 years old are free of charge.

10/ Pets

As a general rule, dogs, except for dogs of category 1 and 2, shall be admitted to the campsites. We require dogs to be kept on a lead within the campsites. Please comply with the rules for hygiene and the environment. The health certificate must be presented at the time of your arrival at the campsite. Anti-rabies booster vaccinations and tattoo certificates are compulsory.

11/ Claims

Any possible claim with respect to a stay must be specified in writing and sent by registered letter with acknowledgement of receipt within 20 days following your stay.

12/ Website

Publications are only indicative and are not contractual. Modification without notice.

13/ The right of publicity

Clients permit Camping Marius to use and air freely their image for the commercial exploitation. If you do not want to be filmed or photographed, we ask you to inform Camping Marius.

14/ Your stay

Clients are responsible for disturbances and nuisance caused by visitors or participants. We reserve the right to ask a guest to leave the campsite following disrespect to any of the above rules or due to any damages caused to campsite property.

15/ Protection of personnel data

Camping Marius uses processing of personal data for commercial and marketing purposes.

According to the « Database and Privacy » law, clients have access to modify, rectify and delete data concerning them.
